The New York State Hamaspik Association is a membership association of human-services providers in 25 counties. It serves as a member cost-sharing consortium for such programs as: retreats for parents, providers and employees; government-mandated staff training sessions; public relations; governmental advocacy; and the 60,000-reader Hamaspik Gazette. It is also the parent organization of Tri-County Care.

Likewise, NYSHA operates Hamaspik Theragen: an Article 16 clinic whose seven satellite branches serve individuals with I/DD, in the five boroughs of New York City, as well as in Orange, Rockland and Westchester Counties.

Tri-County Medical, P.C., offshoot of Hamaspik Theragen, is also operated by NYSHA—filling a care gap with critical off-site medical and therapy services in private residences, Family Care homes, group homes, day programs, and other sites.

Hamaspik Choice is a managed long-term care (MLTC) plan under the auspices of the New York State Dept. of Health (DOH). As a licensed MLTC, Hamaspik Choice is geared for members of Medicaid needing 120 days of nursing-home levels of care —and provides that thorough its network of healthcare providers.

Hamaspik HomeCare

Hamaspik's successful, still-growing foray into home care began in 2010 with one Monsey resident needing it—burgeoning in the following years into a sprawling licensed home-care services agency (LHCSA) comprising thousands of elite employees and satisfied patients across 13 counties. Hamaspik HomeCare continues to provide personal aides, skilled nursing, and a range of therapies. Hamaspik HomeCare is one of New York State's first providers of the Consumer Directed Personal Assistance Services (CDPAS) program, and one of a handful of providers in contract with New York City's Human Resources Administration (HRA) as a CDPAS fiscal intermediary.

Hamaspik of Kings County

Hamaspik brought its reputation to Brooklyn in 1997 with its first office—followed by growing offices, facilities and programs in the Williamsburg and Borough Park districts, and a satellite office servicing the communities of Queens and Long Island. Today, Hamaspik of Kings County services New York City's five boroughs, Long Island, and Suffolk Counties—operating group homes; Day Habilitation, Community Habilitation, After-School Respite, Supported Employment (SEMP), and the Pre-Vocational Skills Training programs. Hamaspik of Kings County also offers the Nursing Home Transition and Diversion (NHTD), and Traumatic Brain Injury (TBI) Waiver programs—along with the Health and Recovery Plan (HARP/HCBS) for adults and children, and a Health Home Care Management Agency for adults and children (CMA) to meet the community's growing need for general health and mental-health services.

Hamaspik of Rockland County

Hamaspik replicated its Orange County success in the late '90s—first opening a Monsey office of Service Coordination and other at-home supports services, followed by the Forshay Briderheim and several more group homes. Today, Hamaspik of Rockland County boasts a growing array of OPWDD supports and services that benefit the growing community of the lower Hudson Valley, from Rockland County to New York City. These include Group Homes, Day Habilitation (DH), Community Habilitation (CH), Site-Based Respite, In-Home Respite, Home Family Care (HFC), Intensive Behavioral Services (IBS), Family Support Services (FSS), Individualized Support Services (ISS), Self-Direction, Supported Employment, and Pre-Vocational programs. Hamaspik of Rockland County also offers other services such as Early Intervention (EI), Nursing Home Transition and Diversion (NHTD) and Traumatic Brain Injury (TBI) waiver programs, Applied Behavior Analysis (ABA), Behavioral Home and Community Based Services for children and adults, and Health Home Care Management.

Hamaspik of Orange County

Hamaspik was born in 1987 in Orange County, NY with what became the Dinev Inzerheim—the agency's first ten-bed Intermediate Care Facility (ICF) which was eventually increased to 12 and then 14 beds, and now converted into four four-bed IRAs (serving a total of 16 individuals). At the same time, Hamaspik began providing CCM – Comprehensive Medicaid Case Management (later called Medicaid Service Coordination (MSC) and now Care Coordination) to families affected by disability—and laying the foundation for what now is New York State's largest Family Care program, servicing and supporting hundreds of families in Orange County. Hamaspik of Orange County now operates ten Individualized Residential Alternative (IRA) group homes; the Early Intervention (EI), Day Habilitation, Community Habilitation and After-School Respite programs; and the Shnois Chaim Senior and Adult Day program. Hamaspik of Orange County also offers the Supportive Employment, Pre-Vocational Skills, and Access-VR programs, as well as the Access to Home, Environmental and Vehicle Modifications (E-Mods), Self-Direction and Fiscal Intermediary programs. Reaching the greater Hudson Valley region, Hamaspik of Orange County provides services in Dutchess, Orange, Putnam, Sullivan and Ulster Counties.
